Methodology, Data Sources, Limitations

#### What is the data source for this report?

This report has been compiled from our online analytical tool, <u>Global Public Companies - Revenue Dashboard (aranca.com</u>). Data for this analytical tool in turn has been curated from income statements that we source from a vendor of Financial APIs, and supplemented with inputs from company filings, where required.

#### Does the Revenue and Rankings dashboard cover all publicly-traded companies?

We estimate our coverage to currently be in the range of 95%, with data on some frontier markets being the main gap. Our ende avor is to reach a 99% coverage level as soon as possible. To that extent, we acknowledge that we may have missed out on one or two companies of interest to you in a particular industry or country.

#### What is your basis of segmentation or classification?

From a segmentation perspective, we have currently used standard industrial classification and HQ country as filters. Going forward, Aranca will leverage its extensive internal expertise of global markets / industries to build its own taxonomy (sub-segments) for different industries. This will make the benchmarking exercise even more relevant and insightful.

#### How frequently are these reports updated?

We will be updating these reports once a fortnight to ensure that latest filings from across the globe are captured as frequently as possible.

#### Have been growth rates been calculated based on reported currency?
